## Resolution 98-10

### A RESOLUTION CREATING AMENDMENT 2 TO THE SEWER USE ORDINANCE

BE IT RESOLVED by the Flathead County Water & Sewer District #1 - Evergreen of Flathead County, Montana on this 29th day of July, 1998 as follows:

WHEREAS, for the sewer service customers of the District that fail to pay their sewer bill, the District's policy is to shut off the District's water service to said customer; and,

WHEREAS, the District has some sewer customers that do not receive water from the District, but rather from a private water well; and,

WHEREAS, in the event of non-payment of the sewer bill to customers without water service from the District, the adoption of a policy is necessary for such customers,

THEREFORE, the following addition to the sewer use ordinance is enacted

Conditions for connection to the sewer collection system:

In addition to complying with all other rules and regulations of the District the following conditions are required to be satisfied prior to the District providing sewer service to any property:

Situation A: In the case of allocated reserves within RSID #132 one of the following conditions must be complied with:

Condition 1: The water service may be connected to the District Water system in conformance with all current main extension policies applicable , or,

Condition 2: In the event water service will be from a well, the customer must:

- a. Provide an easement to the District, which will be registered to and be appurtenant to the title to the subject property, granting access to customer's well, and,
- b. Enter into an agreement with the District, which will be registered to and be appurtenant to the title to the subject property, agreeing to install a device of the District's choice in a location chosen by the District which enables the District to disconnect, and/or lock out the customer's water well pump for non-payment of sewer charges, and,


- c. Purchase a water meter from the District and install the meter on the customer's property, at a location chosen by the District and to the District's satisfaction, thereby providing a method of billing for sewer charges.

Situation B: In the case of non-allocated reserves within the boundaries of RSID #132 and/or in the case of service outside of the boundaries of RSID #132, one of the following conditions must be complied with:


Condition 1: If a District water main is within 200 feet of the property boundary, the water service must be connected to the District water system in conformance with all current main extension policies applicable.

Condition 2: If a District water main is not within 200 feet of a boundary of the subject property, the property owner may apply to provide water service from a well and if approved by the District Board, the following conditions must be complied with:

- a. The customer must provide an easement to the District, which will be registered to and be appurtenant to the title to the subject property, granting access to the customer's well, and,
- b. Enter into an agreement with the District, which will be registered to and be appurtenant to the title to the subject property, agreeing to install a device of the District's choice in a location chosen by the District which enables the District to disconnect, and/or lock out the customer's water well pump for non-payment of sewer charges and,
- c. Purchase a water meter from the District and install the meter on the customer's property, at a location chosen by the District and to the District's satisfaction, thereby providing a method of billing for sewer charges, and
- d. Connect to the District's water service at the District's request and at the customer's expense should a water main ever be located within 200 feet of a boundary of the subject property.
